Dear Sisters,

I hope your holiday season was as fun and enjoyable as ours! I am, at the time of your reading this, in Florida enjoying the sea, sand, sun, and lots of wonderful food. I do wish each of you could be here and enjoy all the wonders with us.

My husband, Bob and I went to the 154<sup>th</sup> Anniversary of the Battle of Wilson's Creek Ceremony on August 10. We viewed the new exhibits and orientation film. A number of dignitaries from Missouri were there and Connie Langum, Park Historian gave information about the Remembrance of the Day. The speaker, Brigadier General Donald Scott, Retired U.S. Army did a wonderful job of tying the idea that the soldier's, both North and South, past and present no matter opinion or outcome, were fighting for our country. He was very inspiring! The activities were completed with the laying of a wreath and a cannon salute.

Bob and I also took a month vacation in Alabama in September and while there went to Historic Fort Morgan. I found out it was actually Fort Boyer during the War of 1812. New construction began in 1819 and in 1833 it was named Fort Morgan. Fort Morgan is located on Mobile Bay and quite interesting. It is almost all brick construction, as I understand forts in these type locations were. The saying "Damn the topedoes and full speed ahead" is remembered from this time as Union Admiral D.G. Farragut made the statement and led his fleet past the guns of the fort which was held by the Confederate troops.

It won't be long until our Missouri Department Convention. As you know it will be held in Springfield on June 3, 4, and 5. One of the exciting activities is that we will be holding a musical evening (Friday) along with a wreath laying. We have invited the Daughters of the Confederacy in an act of solidarity to join us. Everyone is encouraged to wear period dress and enjoy the evening. There is also an excursion planned at Wilson's Creek (Saturday). I know many of you have been at the Battlefield but there have been many changes recently and I think you all would love to see what is there and how the museum has grown. There are some new programs available along with unusual displays so I hope your interest is peaked and you will look forward to this activity.
